**SNOWPLOW FLAG AGREEMENT**

**COUNTY OF NORTHERN LIGHTS** in the Province of Alberta,  
(hereinafter called the "County")  
**OF THE FIRST PART**

**WHEREAS,** the "Owner" is the owner, purchaser or lessee of the following lands:

**WHEREAS,** the Owner desires the County to snowplow his private driveway, located on the above noted lands, when such driveway becomes impassable or hazardous due to snow conditions, now

**THEREFORE,** the County and the Owner for the consideration hereinafter named, agree as follows:

1. The County agrees to snowplow the private driveway of the Owner when so requested by the Owner, who has purchased flag/s and placed them at the entrance to his driveway. However, it shall be understood that **such snowplowing shall only be undertaken at the discretion of the plow/ grader operator in the order of priority as set by County policy.**
2. a) The Owner hereby agrees to pay to the County a fee of \$30 plus GST per regular flag, or \$10 plus GST per senior flag or disabled or have a medical condition whom have been CAO approved (price subject to annual review by the County).  
b) The Owner hereby agrees that each Flag purchased will entitle him to have up to 400m of his driveway snowplowed by the County to the mutually agreed upon limits of the Owner's property.  
c) **The Owner hereby agrees that the maximum length of driveway to be plowed for one Flag is 400m.** Additional plowing will require another flag, or more flags.  
d) The Owner hereby agrees that the flag or flags placed at the entrance to the Owner's driveway will be picked up by the plow operator and returned to the County upon completion of each snowplowing.
3. The Owner hereby covenants and agrees that he will at all times indemnify and save harmless the County, it's servants, contractors, agents and employees from and against all loss, damage or injury however caused, which may at any time during the continuance of this Agreement occur to any person or the person including the Owner.
4. The Owner shall not assign or transfer his interest in this Agreement without first obtaining the written consent of the County.
5. The County shall have the right to refuse to snowplow any private driveway that in the opinion of the snowplow operator will be hazardous or difficult to snowplow.
6. The Owner shall not be entitled to a refund for any purchased flags unless he moves from the County.
7. The flag at all times remains the property of the County.
