

**BYLAW NO. 13-11-313**

**COUNTY OF NORTHERN LIGHTS  
IN THE PROVINCE OF ALBERTA**

**BEING A BYLAW TO AUTHORIZE THE ESTABLISHMENT OF ELECTORAL  
BOUNDARIES FOR MUNICIPAL ELECTION PURPOSES**

**WHEREAS** the Municipal Government Act, Chapter M-26.1, revised 2000, and amendments thereto authorizes Council to pass bylaws to divide the municipality into wards and establish their boundaries; and

**WHEREAS** the Council deems it expedient to adjust the electoral boundaries to better represent the voting location patterns of electors; now

**THEREFORE**, the Council of the County of Northern Lights, duly assembled, hereby enacts as follows:

1. That for the purpose of holding municipal elections, the County of Northern Lights is divided into seven (7) electoral divisions as described in Schedule "A" and identified in Schedule "B";
2. That one (1) Council member be selected from each electoral division; and
3. That Ministerial Order 160/93 is hereby rescinded.

Schedule "A" Bylaw  
Electoral Division  
County of Northern Lights

Division 1

All that portion of County of Northern Lights lying west of the east bank of the Peace River, in: Range 20, Township 86; and all that portion east of the Whitemud River in Range 20, Townships 87 and 88

Range 21 and 22 inclusive, Townships 84 to 86 inclusive;

All of the above described lands lying west of the 5<sup>th</sup> meridian.

Division 2

All that portion of County of Northern Lights lying west of east bank of the Peace River in: Ranges 23 to 26 inclusive, Townships 84 and 85;

All of the above lying west of the 5<sup>th</sup> meridian.

Division 3

All that portion of County of Northern Lights lying west of the east bank of the Peace River in:

Ranges 23 to 26 inclusive, Townships 86 to 88 inclusive; excluding sections 25 to 36 in Township 88, Range 23;

All of the above lands lying west of the 5<sup>th</sup> meridian.

Range 1, Townships 86 to 88 inclusive;

All of the above described lands lying west of the 6<sup>th</sup> meridian.

Division 4

All that portion of County of Northern Lights lying west of the east bank of the Peace River in; Range 20, Townships 87 to 89 inclusive; excepting thereout that area east of the Whitemud River in Range 20, Townships 87 and 88;

Ranges 21 and 22, Townships 87 to 90 inclusive;

Range 23, Township 88, Sections 25 to 36 inclusive;

Ranges 23 to 26, Townships 89 to 90 inclusive, excepting thereout, that portion of Range 23 Township 90, lying within the boundaries of the Hamlet of North Star, including that portion of the northeast quarter of section thirty-two (32) lying northeast of Road Plan 2239 JY, which includes Plan 3447 LZ, Plan 3021 K.S. – Block A and Plan 6680 E.T. – Block one (1) and block four (4); and that portion of the northwest quarter of Section thirty-three (33), which includes Plan 2879 E.T – Blocks two (2) and three (3), Plan 3392 H.W. – Block seven (7);



All of the above described lands lying west of the 5<sup>th</sup> meridian.

Range 1, Townships 89 and 90;

All of the above lying west of the 6<sup>th</sup> meridian.

#### Division 5

All that portion of County of Northern Lights lying west of the east bank of the Peace River in:  
Range 19, Township 95;

Range 20, Townships 93 and 94;

That portion of Range 20, Township 95 lying east and south of the Notikewin River;

Range 21, Townships 91 to 93 inclusive;

That portion of Range 21, Township 94 lying east of the Notikewin River;

That portion of Range 21, Township 95 lying south and east of the Notikewin River;

Range 22, Township 91;

Those portions of Range 22, Townships 92, 93 and 94 lying east of the Notikewin River;

That portion of Range 23, Township 92 lying east of the Notikewin River;

Ranges 23 to 25 inclusive, Township 91;

That portion of Range 23, Township 90, lying within the boundaries of the Hamlet of North Star, including that portion of the northeast quarter of section thirty-two (32) lying northeast of Road Plan 2239 JY, which includes Plan 3447 LZ, Plan 3021 K.S. – Block A, and Plan 6680 E.T. – Block one (1) and block four (4); and that portion of the northwest quarter section of Section thirty-three (33), which includes Plan 2879 E.T. – Blocks two (2) and three (3), Plan 3392 H.W. – Block seven (7);

All of the above described lands lying west of the 5<sup>th</sup> meridian.

Range 1, Township 91;

All of the above described lands lying west of the 6<sup>th</sup> meridian.

#### Division 6

All that portion of County of Northern Lights lying west of the east bank of the Peace River in:  
Range 19, Township 97;

That portion of Range 20, Township 95 lying north west of the Notikewin River;

Range 20, Townships 96 and 97;

Those portions of Range 21, Townships 94 and 95 lying north west of the Notikewin River;

Range 21, Townships 96 and 97;

Those portions of Range 22, Townships 92, 93 and 94 lying west of the Notikewin River;

Range 22, Townships 95 to 97 inclusive;

That portion of Range 23, Township 92 lying west of the Notikewin River;

Range 23, Townships 93 to 97 inclusive;

Ranges 24 and 25, Townships 92 to 97 inclusive;

All of the above described lands lying west of the 5<sup>th</sup> meridian.

That portion of Range 1, Townships 92 to 96 inclusive;

All of the above described lands lying west of the 6<sup>th</sup> meridian.

#### Division 7

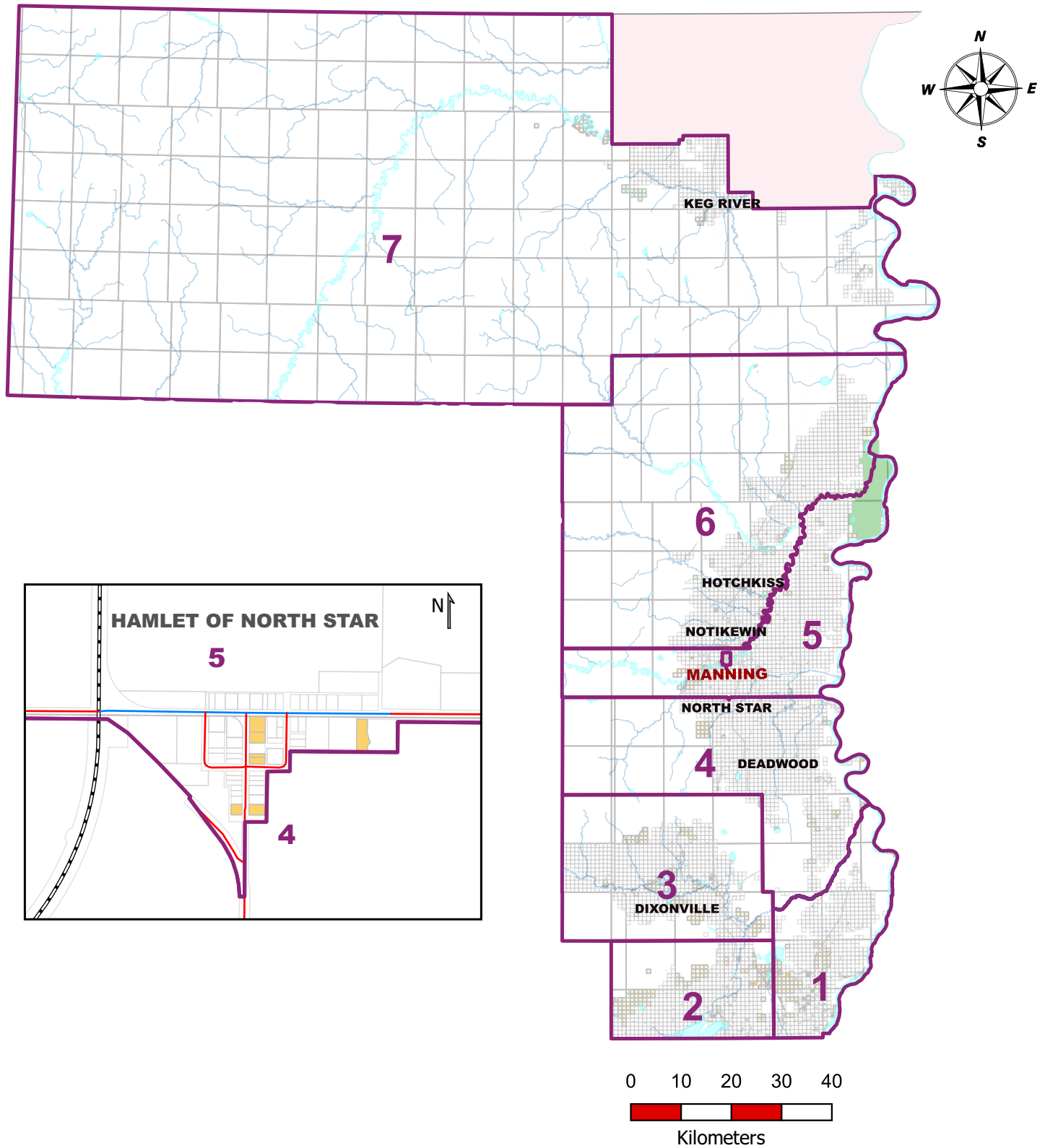
All that portion of County of Northern Lights lying west of the east bank of the Peace River in:  
Ranges 18 to 25 inclusive, Townships 98 to 104 inclusive, excluding the Paddle Prairie Metis Settlement;

All of the above described lands lying east of the 5<sup>th</sup> meridian.

Ranges 1 to 12 inclusive, Townships 97 to 104 inclusive;

All of the above described lands lying west of the 6<sup>th</sup> meridian.
