## Natalie read the following into the record:

The purpose of this Land Use Bylaw (LUB) amendment is to redesignate a 4.0 ha (9.9 ac) portion of NW 9-88-21-W5 from the Agriculture General (A) District to the Country Residential General (CR1) District, as shown in the attached sketch.

Chair Ungarian requested confirmation that notification requirements (newspaper ads, announcements, time frames, etc.) had been met.

Notice of the public hearing for the proposed amendment was advertised in the Mile Zero Banner Post on July 5 and July 12, 2023, and on the County website and its social media channels. No letters or comments from adjacent landowners were received.

Chair Ungarian stated the Rules of Conduct that would be followed during the hearing.

Chair Ungarian called for the PRESENTATION

The proposed bylaw is to redesignate a 4.0 ha (9.9 ac) portion of NW 9-88-21-W5 from the Agriculture General (A) District to the Country Residential General (CR1) District as shown in the sketch.

The amendment is required to accommodate the subdivision of a country residential lot from a portion NW 9-88-21-W5. The proposed lot is the second lot out of the quarter section, and rezoning is required to allow the subdivision.

The proposed lot contains a house, a shed, a dugout, and a septic tank that is connected to an underground septic field approximately 3 m east of the existing residence. The quarter section and surrounding area is predominately flat, consists of trees, brush, agricultural land, and some low-lying potential wetland areas.

There is a developed farmstead to the north of the subject quarter section situated across Highway 743 and to the west across Range are Road 214 partially covered in trees.

The surrounding lands to are zoned are zoned A District and developed with farmsteads. The surrounding areas consist of undeveloped quarter sections that are predominantly in agricultural production except for a low-lying creek area that runs adjacent to the south property line of the existing lot.

According to a 2016 Lands Assessment report, the subject land has a Canada Land Inventory (CLI) rating of Class 6 (severe soil limitations with the capability for producing some perennial forage crops) and Class 7 (no capability for permanent pasture) which is not considered to be Better Agricultural Land in accordance with the definition in the MDP.

The proposed lot has legal and physical access from Range Road 214 and the balance of the existing Lot 1 Block 1 has legal and physical access from Highway 743. Legal access to the balance of the quarter section is provided via Range Road 214 but does not have physical access. Construction of an approach to the balance is required prior to registration of the proposed subdivision.

Chair Ungarian called for WRITTEN SUBMISSIONS in support of the proposed amendment. To date, no written submissions in support have been received.
