BYLAW NO. 24-32-492

COUNTY OF NORTHERN LIGHTS IN THE PROVINCE OF ALBERTA

BEING A BYLAW PROVIDING FOR THE CLOSURE OF A CERTAIN PUBLIC ROADWAY WITHIN THE TERRITORIAL LIMITS OF THE COUNTY OF NORTHERN LIGHTS

WHEREAS Section 18(1) of the *Municipal Government Act,* Revised Status of Alberta 2000 Chapter M-26, provides that a Council of a "municipality has the direction, control, and management of all roads within the municipality."; and

WHEREAS Section 22(1) of the *Municipal Government Act* states "No road in a municipality that is subject to the direction, control, and management of the municipality may be closed except by bylaw"; and

WHEREAS notice of the intention to close the public road described in "Schedule A" has been given in accordance with Section 22(2) of the *Municipal Government Act*; and

WHEREAS Section 658 of the *Municipal Government Act*, Revised Status of Alberta 2000 Chapter M-26, empowers a municipality to cancel a plan of subdivision in whole or in part; and

WHEREAS the Municipality has not received any objections by persons claiming to be prejudicially affected by the road closure; and


WHEREAS the Council of the County of Northern Lights considers it desirable, prudent, and in the best interest of the safety and well-being of the public to close said roadway;

NOW THEREFORE LET IT BE RESOLVED that the County of Northern Lights, duly assembled, hereby enacts the following,

- 1. That the public roadway shown in "Schedule A" [attached] and described as 398.5 meters of the statutory road allowance (Township Road 950) forming part of the north boundary of the Northwest quarter (NW) of Section Thirty-five (35) Township Ninety-four (94) Range Road Twenty-two (22) West of the Fifth Meridian (W5) beginning at the quarter's north-west corner boundary is to be closed to public travel.
- 2. That Road Plan 2359PX be cancelled.
- 3. That the land occupied by cancelled Road Plan 2359PX be consolidated with NW 35-94-22-W5M.

- 4. Upon the THIRD AND FINAL reading of this Bylaw, the proper authorities of the County of Northern Lights will remove the access point of Township Road 950 from Range Road 222A and return the roadway to an undeveloped road allowance.
- 5. This bylaw shall come into effect upon the date of the final passage thereof.


