A. Public Hearing at 11:00 a.m. for Bylaw No. 24-32-492

Chair Terry Ungarian declared the Public Hearing for Bylaw No. 24-32-492 open at 11:01 a.m.

Chair Ungarian welcomed all participants.

Chair Ungarian asked that the nature of the proposed bylaw be read into the record. Charles Schwab, Director of Public Works read the following into the record:

In accordance with the County's Road Closure Policy, Bylaw No. 24-32-492 was given First Reading at the Tuesday, May 14, 2024 council meeting.

Today's Public Hearing is to allow for any public to make comment.

Chair Ungarian requested confirmation that notification requirements (newspaper ads, announcements, time frames, etc.) had been met.

The Bylaw was posted in the Mile Zero Banner Post on May 15 and 22, 2024 and on the County's website.

Chair Ungarian dispensed with stating the Rules of Conduct that would be followed during the hearing.

Chair Ungarian called for the PRESENTATION

The Bylaw is to close 398.5 meters of statutory road allowance (Township Road 950) forming part of the north boundary of the Northwest quarter of section 35 Township 95, Range Road 22 west of the fifth meridian beginning at the quarters north-west corner boundary and road plan 2359PX is to be cancelled.

The reasoning is that the drainage ditch channel along the north side of the road that flows into Gravina Creek is eroding causing a sever safety hazard.

We have discussed the closure with the primary landowner, and they have no concerns regarding the closure. A new access will be established for them along the northwest quarter off range road 222.

Chair Ungarian called for any WRITTEN SUBMISSIONS in support of the proposed bylaw. To date, no written submissions in support were received.

Chair Ungarian called for any WRITTEN SUBMISSIONS opposed to the proposed bylaw. To date, no objections have been received or expressed.

Chair Ungarian asked that the nature of the proposed amendment be read into the record. Natalie read the following into the record:

The purpose of this Land Use Bylaw (LUB) amendment is to redesignate a 4.0 ha (10.0 ac) portion of NE 35-86-26-W5M from the Agriculture General (A) District to the Country Residential General (CR1) District,

The proposed amendment is being considered in conjunction with the proposed subdivision application 24NL05.

Chair Ungarian requested confirmation that notification requirements (newspaper ads, announcements, time frames, etc.) had been met.

Notice of the public hearing for the proposed amendment was advertised in the Mile Zero Banner Post on May 29th and June 5th, 2024, and on the County website. No comments were received.

The proposed LUB amendment was circulated to affected stakeholders for their review and comment. To date, referral agencies have had no concerns with the amendment or did not provide comment.

Chair Ungarian stated the Rules of Conduct that would be followed during the hearing.

#### Chair Ungarian called for the PRESENTATION

The purpose of this Land Use Bylaw (LUB) amendment is to redesignate a 4.0 ha (10.0 ac) portion of NE 35-86-26-W5M from the Agriculture General (A) District to the Country Residential General (CR1) District.

The LUB amendment is required to accommodate the subdivision of a country residential lot from a portion NE 35-86-26-W5M. The proposed lot is the second lot out of the quarter section, and rezoning is required to allow the subdivision.

The proposed lot contains a residence and related improvements, several sheds and a holding tank (septic). The quarter section and surrounding area is predominately flat, consisting of trees, brush, agricultural land, and some low-lying wetland areas.

There is an existing 7.1-hectare (17.67 acre) subdivision with a developed farmstead to the immediate north of the proposed lot.

The surrounding lands are zoned A District and Crown Land (CL) District and consists of largely undeveloped quarter sections that are either used for agricultural production, are treed, or have a farmstead.

A review of SPIN2, Alberta's Spatial Information System, indicates that the proposed lot has a mixed Canada Land Inventory (CLI) rating. The lot is split diagonally from the northwest corner to the southeast corner with two soil ID classifications. The northeast half of the proposed subdivision is classified as Area ID 454 (80% Class 4 "Severe limitations", Subclass D "Undesirable soils structure", and 20% Organic soil) and the southwest half of the proposed subdivision is classified as Area 469 (100% Organic soil).

Although Class 4 soils are considered Better Agricultural Land (BAL) by the Municipal Development Plan (MDP), the presence of these soils and soils indicate a poorer soil quality. The MDP allows the Development Authority to exempt lands from the BAL definition, specifically when those lands are "...compatible with adjacent land uses". In this instance the Development Authority may exempt the proposed parcel area from the BAL definition as it is compatible with existing subdivisions and land uses in the surrounding area.

The proposed lot and the balance of the quarter section has legal and physical access from Range Road 261.

The proposed amendment complies with the Municipal Development Plan as Policy 4.2.5 and 5.2.2 allows for the subdivision of a second lot from a quarter section provided that it is a maximum lot size of 4.0 ha (10 acres), contains an existing habitable residence and that the maximum density does not exceed three lots per quarter section, including the balance.

2. That the applicant/owner dedicate a 5.0 m road right-of-way by caveat along the east boundaries of the proposed lot and the balance of the quarter section adjacent to the road allowance for Range Road 261, for future road widening pursuant to Section 662 of the Municipal Government Act;

3. That the applicant/owner enter into a development agreement with the County of Northern Lights to include, but not be limited to, the upgrading of the existing approaches to the proposed lot and balance of the quarter section, if necessary;

4. That the applicant/owner adhere to the 2021 Alberta Private Sewage System Standard of

Practice and all required setbacks;

5. That the applicant/owner enter into a cross-lot access agreement with the owner of Lot 1, Block 1, Plan 9020330. The easement agreement shall be registered on title and drafted to benefit current and future landowners, not named individuals;

6. That the applicant/owner carry forward and/or provide new agreements, caveats



easements and/or rights-of-way in accordance with municipal requirements, and agency and/or utility company requirements as identified in the Comments from Referral Agencies Section of this report;

- 7. That the applicant/owner pay all outstanding property taxes on the land proposed to be subdivided or have arrangements made which are satisfactory to the County of Northern Lights; and
- 8. That the applicant/owner contact an Alberta Land Surveyor for the preparation of a Plan of Subdivision suitable for registration at the Alberta Land Titles Office to obtain title(s) under this decision.

- 5. That the applicant/owner contact an Alberta Land Surveyor for the preparation of a Plan of Subdivision suitable for registration at the Alberta Land Titles Office to obtain title(s) under this decision; and
- 6. That the applicant/owner pay all outstanding property taxes on the land proposed to be subdivided or have arrangements made which are satisfactory to the County of Northern Lights.
