

BYLAW NO. 06-32-183

**MUNICIPAL DISTRICT OF NORTHERN LIGHTS NO. 22
IN THE PROVINCE OF ALBERTA**

**BEING A BYLAW PROVIDING FOR THE CLOSURE
OF A CERTAIN PUBLIC ROADWAY WITHIN THE TERRITORIAL LIMITS OF
THE MUNICIPAL DISTRICT OF NORTHERN LIGHTS NO. 22.**

WHEREAS Section 22 of the Municipal Government Act, being Chapter M-26 of the Revised Statutes of Alberta, 2000, as amended, provides that the Council of a Municipality may, with the approval of the Minister of Alberta Transportation & Utilities, pass bylaws for the purpose of closing the whole or any portion of any road; and

WHEREAS application has been made to Council to have this roadway closed, and the Municipal District of Northern Lights No.22 ("the Municipality") considers it desirable and in the public interest to close and sell that public roadway described in "Schedule A", which is attached to and forms part of this Bylaw; and

WHEREAS notice of the Municipality's intention to close and sell the public roadway described in Schedule "A", in the manner specified in Section 22 of the said Municipal Government Act, has been given to every person assessed as or registered as the owner of the land abutting upon the portion of the said public roadway proposed to be closed; and

WHEREAS notice of the Municipality's intention to close and sell the public roadway described in Schedule "A" has been published in the Mile Zero News and the Banner Post on 9th August, 2006 and 16th August, 2006 and circulated by way of letter to affected parties; and

WHEREAS the Municipality has not received any objections to the proposed closure and sale of the public roadway described in "Schedule A" by any person claiming to be prejudicially affected by the proposed closure and sale; now

THEREFORE the Council of the Municipal District of Northern Lights No.22, duly assembled, hereby enacts as follows:

1. Subject to the approval of the Minister Responsible for Transportation, the public roadway located within the Hamlet of North Star, described as

and shown in "Schedule A" attached to and forming part of this Bylaw, is hereby closed.

2. Upon the approval of the Minister Responsible for Transportation, and upon the final passage of this Bylaw, the proper officers and officials of the Municipality are hereby authorized and empowered to do all acts necessary or expedient to cause to be issued in the name of the Municipality a certificate of title to the said public roadway closed pursuant to the provisions of this Bylaw.
3. Upon the approval of the Minister Responsible for Transportation, and upon the final passage of this Bylaw, the proper officers and officials of the Municipality are hereby authorized and empowered to execute, on behalf of the Municipality, an agreement for the sale of the said public roadway closed pursuant to the provisions of this Bylaw.
4. This Bylaw shall take effect as and from the third and final reading.






SCHEDULE "A"
