

**BYLAW NO: 10-32-274**  
**COUNTY OF NORTHERN LIGHTS**  
**IN THE PROVINCE OF ALBERTA**

**BEING A BYLAW PROVIDING FOR THE CLOSURE OF AN UNDEVELOPED ROAD ALLOWANCE WITHIN THE TERRITORIAL LIMITS OF THE COUNTY OF NORTHERN LIGHTS.**

**WHEREAS** Section 22 of the Municipal Government Act, being Chapter M-26.1 of the Revised Statutes of Alberta, 1994, as amended, provides that the Council of a County may, with the approval of the Minister Responsible for Transportation, pass bylaws for the purpose of closing the whole or any portion of any road; and

**WHEREAS** application has been made to Council to have this undeveloped road allowance closed, and the County of Northern Lights ("the County") considers it desirable to close the undeveloped road allowance shown and described in "Schedule A", which is attached to and forms part of this Bylaw; and

**WHEREAS** notice of the County's intention to close the undeveloped road allowance described in Schedule "A", in the manner specified in Section 22 of the said Municipal Government Act, has been given to every person assessed as or registered as the owner of the land abutting upon the portion of the said service road; and

**WHEREAS** notice of the intention of Council to pass a bylaw has been given in accordance with Section 606 of the Municipal Government Act; and

**WHEREAS** the County has not received any objections to the proposed closure of the undeveloped road allowance described in "Schedule A" by any person claiming to be prejudicially affected by the proposed closure; now


**THEREFORE** the Council of the County of Northern Lights, duly assembled, hereby enacts as follows:

1. "Subject to the approval of the Minister Responsible for Transportation, the undeveloped road allowance shown in Schedule "A" [attached] and described as:
  1. **MERIDIAN 5 RANGE 23 TOWNSHIP 92**  
**ALL OF THE ORIGINAL GOVERNMENT ROAD ALLOWANCE ADJOINING THE WEST BOUNDARY OF THE SW 1-92-23-W5M.**  
**EXCEPTING ALL MINES AND MINERALS**
  2. **PLAN 229EU**  
**ALL THAT PORTION OF ROAD WHICH LIES EAST OF THE PRODUCTION SOUTH EASTERLY OF THE NORTH EASTERLY LIMIT OF SAID ROAD AS DEFINED BY THE COURSE BETWEEN I.P.P.R. 2 TO I.P.P.R. 3 AS SHOWN ON THE SAID PLAN.**  
**EXCEPTING THEREOUT ALL MINES AND MINERALS**

to be closed and consolidated with SW 1-92-23-W5M upon approval of a subdivision to consolidate the two parcels.


2. Upon the approval of the Minister Responsible for Transportation, and upon the final passage of this Bylaw, the proper officers and officials of the County are hereby authorized and empowered to do all acts necessary or expedient to cause to be issued in the name of the County a certificate of title to the said undeveloped road allowance closed pursuant to the provisions of this Bylaw.
3. Upon the approval of the Minister Responsible for Transportation, and upon the final passage of this Bylaw, the proper officers and officials of the County are hereby authorized and empowered to execute, on behalf of the County, an agreement for the sale of the said undeveloped road allowance closed pursuant to the provisions of this Bylaw.
4. This Bylaw shall take effect as and from the third and final reading.


